If you intend* to send your child to a non-public or out-of-district school in **September, 2010**, and he/she will need school bus service, this application must be completed and returned by fax or mail to the address listed on the form by no later than **April 1, 2010**. **(NOTIFICATION OF ADMISSION MAY BE LATER THAN APRIL 1 – FILE ANYWAY)*

All eligible students will be routed and this information will be communicated to you in August along with the bus company name and telephone number. Applications submitted for schools located more than **15 miles** from the student’s home would not be approved.

If for some reason you change the school your child will be attending, or you know that your child will not need school bus service in **September, 2010**, it is very important for you to call me with this information.

NEW YORK STATE LAW REQUIRES:

1. That requests for transportation to private and parochial schools must be signed and returned to the public school district by APRIL 1ST of each year.
2. That transportation will be furnished only to pupils residing in the school district. (In this case, Mt. Pleasant School District).
3. That transportation will be furnished to all pupils attending private and parochial schools, providing such schools are not more than fifteen miles distance from their homes, as measured by the nearest available route and filing was MADE BY APRIL 1ST.
4. That the pupil be five years old by December 1st to be eligible for private transportation.
